H2020-Energy Efficiency Research & Innovation. Demand response in blocks of buildings. Deadline: 4 June 2015

At the level of a block of buildings, the focus should be on real time optimisation of energy demand, storage, supply including self-production when applicable, using intelligent energy management systems with the objective of reducing the difference between peak power demand, minimum night time demand, thus reducing costs and greenhouse gas emissions.

Scope: the focus should be on the creation of innovative IT ecosystems that would develop services and applications making use of information generated by energy consumers (e.g. through social networks) or captured from sensors (e.g. smart meters, smart plugs, social media) and micro-generation.
